The use of the LEI has been mandated by the European Securities and Markets Authority (ESMA) for the reporting of derivative transactions to Trade Repositories under European Market Infrastructure Regulation (EMIR). Under MiFID II and Market Abuse Regulation (MAR), market operators are required to collate an LEI for each issuer with securities admitted to trading. All investment firms subject to MiFID II will be required to retain a valid LEI. Firms subject to the MiFID II transaction reporting obligations will not be able to execute a trade on behalf of a client who is eligible for an LEI and does not have one.

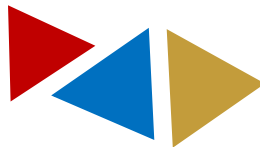

In March 5, 2024, Elite Capital & Co. Limited has become a full member of the China-Britain Business Council ("CBBC") strengthens its economic, political and financial influence in the world, and achieves its vision of supporting government projects through the Government Future Financing 2030 Program.

CBBC plays an important role in helping shape bilateral relations between the UK and China through its close links to the UK Government and the Devolved Administrations; the Chinese Government at national, provincial and municipal level; and the British and Chinese Embassies.

The CBBC's history dates back to the early 1950s when British companies were among the first to trade with Communist China. That was the 48 Group of Companies (established in April 1954). At the same time, the British government had a semi-official trade

body known as the Sino-British Trade Council which promoted British participation in trade fairs and exhibitions in China. Although the UK was the first Western country to recognize the People's Republic of China, the PRC did not fully recognize the UK until 1972.

The China–Britain Trade Group (“CBTG”) was established in 1991 when the 48 Group merged with Sino-British Trade Council, at the instigation of the (then) UK Department of Trade and Industry.



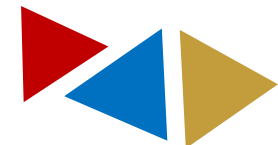
The early 1990s saw a renewal of high-level visits from China to the UK. In November 1992 Vice-Premier Zhu Rongji was the first Chinese leader to take part in a seminar with British business in the UK, when the Stock Exchange was the venue for presentations from privatized industries, organized by CBTG and the Stock Exchange.

In 1998 the organization changed its name to the China–Britain Business Council (“CBBC”), to reflect the growth of all round business between the UK and China encompassing investment, trade, licensing and other forms of business activity.

In November 1999, the UK received the first head of state from the People’s Republic of China, Jiang Zemin, who was greeted by a CBBC organized business lunch at the Banqueting House.

September 2019 AGM held a particular significance as it marked CBBC’s 65th anniversary, and welcomed Sir Sherard Cowper-Coles as CBBC’s new Chair, and in addition Lord Sassoon was nominated to become CBBC’s first President.

The name of Elite Capital & Co. Limited was sent within three official missions to outer space between 2016 and 2020, where its name was placed inside the spacecraft before launch into space.

**2016** - OSIRIS-REx is a NASA mission, and Messages to Bennu is a partnership between the Planetary Society and the University of Arizona. NASA chose the University of Arizona to lead its third New Frontiers Mission.

OSIRIS-REx has travelled to a near-Earth asteroid called Bennu and will bring a small sample back to Earth for study. The mission was launched on September 8, 2016 from Cape Canaveral Air Force Station. As planned, the spacecraft has reached Bennu in 2018 and return a sample to Earth in 2023.

Most importantly of all, the name of Elite Capital & Co. Limited will remain outside the boundaries of Earth's atmosphere to swim in outer space throughout the ages because it will remain inside the part of the craft that will stray on the asteroid.

**2018** - InSight, short for Interior Exploration using Seismic Investigations, Geodesy and Heat Transport, is a Mars lander designed to give the Red Planet its first thorough check-up since it formed 4.5 billion years ago. It is the first outer space robotic explorer to study in-depth the "inner space" of Mars: its crust, mantle, and core.

Studying Mars' interior structure answers key questions about the early formation of rocky planets in our inner solar system - Mercury, Venus, Earth, and Mars - more than 4 billion years ago, as well as rocky exoplanets. InSight also measures tectonic activity and meteorite impacts on Mars today.

The lander uses cutting edge instruments, to delve deep beneath the surface and seek the fingerprints of the processes that formed the terrestrial planets. It does so by measuring the planet's "vital signs": its "pulse" (seismology), "temperature" (heat flow), and "reflexes" (precision tracking).

This mission is part of NASA's Discovery Program for highly focused science missions, and Elite Capital & Co. Limited is proud that its name was placed inside this spacecraft.

**2020** - The Elite Capital name is also placed inside Mars 2020 Mission Perseverance Rover. The Mars 2020 Perseverance Rover will search for signs of ancient microbial life, which will advance NASA's quest to explore the past habitability of Mars. The rover has a drill to collect core samples of Martian rock and soil, then store them in sealed tubes for pickup by a future mission that would ferry them back to Earth for detailed analysis. Perseverance will also test technologies to help pave the way for future human exploration of Mars.

Strapped to the rover's belly for the journey to Mars is a technology demonstration - the Mars Helicopter, Ingenuity, may achieve a "Wright Brothers moment" by testing the first powered flight on the Red Planet.

There are several ways that the mission helps pave the way for future human expeditions to Mars and demonstrates technologies that may be used in those endeavours. These include testing a method for producing oxygen from the Martian atmosphere, identifying other resources (such as subsurface water), improving landing techniques, and characterizing weather, dust, and other potential environmental conditions that could affect the future.
